



Public Inquiry into White Collar Crimes

Target: The Lord Chancellor, Business Minister, Justice and Treasury Select Committee

Based on the evidence published on the web so far, we, the undersigned, request a Public Inquiry into White Collar Crimes. In its coalition programme, the Government announced that it would take white collar crime as seriously as any other.

However, victims are still far from any hope of ever getting redress or restitution from financial exploitation and legal oppression, let alone any compensation for loss of earnings, loss of homes and fraudulent bankruptcies due to the non-investigation of crimes by police and the abuse of process in courts.

We therefore ask the Government to take responsibility as [Compensator of Last Resort](#) and to put right what predecessors have done wrong for decades.

26 We have, after three years, now got both a criminal investigation by the police into the fraud we uncovered (it is in its 12th month) and an FSA investigation under Section 168 of FSMA 2000 of the Bank involved (in its 11th month). However, we still have had no redress from the Bank - rather the opposite involving 22 eviction hearings which we have personally resisted. That aspect has been adjourned indefinitely at the Bank's request.

32 I support this Petition for all those who have suffered at the hands of White Collar Criminals. I am a Victim of White Collar Criminals. They make no secret of their "Contacts" - they appear to be above the Law. It appears they are even allowed to issue false documents (forgeries) and mis-lead and manipulate the Courts Services in their quest to gain money from their victims. If the Local Authorities are protecting them where can people go for justice?

44 I am a victim of white collar crime and lost my home and all means to practice due to failure of the responsible authorities to act.

49 Under Helen Clift Solicitor within the Official Solicitor of the Supreme Court office things have not changed since 2005. Hospital Medical Director Report reference: *Leonard Lawrence*:

1 He was then medicated to the extent that he lost mental capacity.

2 During the period the Official Solicitor of the Supreme Court acted as his Guardian ad Litem, three Court of Protection medical certificates (CP3s) had been obtained but not registered with the Court of Protection

61 I was psychologically, emotionally and financially abused by a corrupt Edinburgh lawyer. My son's Rights were also abused. I was told by the so-called Law Society of Scotland, the Fraud Squad and the Procurator Fiscal to 'go away and be a good little victim' - the Scottish Justice System is riddled with corruption.

69 My 3 children were entered into Manchester High Court Chancery Division totally without either their knowledge or that of myself and my husband at the time. I never instructed a solicitor, but had an "unknown" barrister acting for me, I learnt at a later date, that he was from Wilberforce Chambers in Lincoln's Inn. When I took the firm of solicitors to Court by myself, they stated that they had never acted for me, though they had taken money from my dear late mother's estate. Please help.

70 I have been wronged by the police. As a victim of domestic violence I have made police statements, have then been threatened, manipulated and harassed by the defendant before the trial, the police dissuaded me from making another statement, saying I could say all this in court, where I was then told I would have had to make the statement beforehand, thus I was not heard in court, and the person who squeezed my neck and shouted 'I'll kill you' was found 'not guilty' resulting in further trauma.

71 White collar crime follows the same pattern: they network with each other, they consolidate each other's contact to insure there is no investigation, no redress, no remedy, and no possible chance of the victim recovering their losses. The government's complicity in failing to support and speak out on behalf of victims allows the criminals protection and gives them greater powers to remain in the shadows, government, by their inaction allows corruption and fraud to flourish and grow.

79 The government are quick to clamp down on looters who thief a few hundred pounds, but turn a blind eye and totally white collar crime, fraud, and corruption which runs into many thousands of pounds per fraudster. Take my case for example, £10,000 fraudulently taken from salary by a solicitor who obtained a court order to do so, and I was not informed of that court hearing. I am now surviving on benefits at the expense of the taxpayer.

Political Observations

3 It is not the Citizens' Government! But Her Majesty's Government, and we the people are secretly enslaved. The thefts & frauds by bankruptcy have been going on for years by corrupt civil servants in the courts, Insolvency Service, Land Registry, and by HM agents: solicitors, barristers, judges & police. All of these HM agents have sworn allegiance to the sovereign, not the citizens. Because all our MPs, local councillors etc. all swear the same allegiance they are accomplices to thefts etc.

6 When Government ignores the purpose for which it was elected and lawlessness ensues as a direct result of their failures, then the electorate have a right to protest and a right to expect that such injustices be rectified by Government and be seen to be rectified and not ignored, if they wish to keep any credibility at all!

11 The pin-stripe mafia is destroying society and people's lives. The government must act as a matter of urgency.

12 HM Partnership is at the root of this evil and not dissimilar to Radical Monopoly, the concept elaborated by Ivan Illich.

13 Too many promises to investigate white collar fraud are not kept but quietly dropped.

15 We need to get rid of the elite in Governments who make the so called laws of the land and find good honest people to run the country which will protect the Nation.

19 ALL MEN ARE BORN EQUAL BEFORE THEIR CREATOR. So what went so wildly wrong when the Judiciary and Legal Profession evolved into what it is today? An urgent clean up is needed - and the PEOPLE will bring that change, first thru awareness, 2nd thru determination and commitment to Truth, 3rd thru organising themselves with a unified voice and purpose. Some serious QUALITY CONTROL is needed in our courts and Government workers! Less 'complaint systems' and more self-governance and self-reliance.

The financial sector itself should be calling for this enquiry so that those men/women of integrity left (there must be some), can get on with running banks properly and honestly. As things stand, all bankers are tarred with the same brush - the same brush that's painting a picture of Britain as a dysfunctional and corrupt Country.

31 Accountability must be demanded of those occupying positions of privilege and responsibility.

33 Who can we trust? It's nice to know that some MPs are interested in justice. The question is how many?

37 Treasonous courts will pay with REAL Justice as the true justice cannot and will not be ignored - this will result in many Judges being imprisoned and most likely hung!

Legal Comments

77 Use our still existing Magna Carta Law and not the corrupt and treason ways!!!
